ABSTRAK

Latar Belakang: Kekerasan seksual merupakan semua tindakan seksual atau tindakan lain yang diarahkan terhadap seksualitas dengan paksaan dalam situasi apapun tanpa memandang status hubungannya dengan korban, meliputi pemeriksaan fisik ataupun bentuk non-kontak lainnya (WHO, 2017). Perbedaan usia korban dan status hubungan korban dengan pelaku akan memengaruhi prevalensi pelaporan ke pihak kepolisian.

Tujuan: Mengetahui hubungan antara usia korban dan status hubungan korban dengan pelaku terhadap prevalensi pelaporan kasus kekerasan seksual di Rumah Sakit Umum Dr. Kariadi Semarang pada Tahun 2018 – 2022.

Metode: Penelitian ini menggunakan jenis penelitian obsevasional analitik dengan desain penelitian cross sectional, menggunakan analisis univariat dan bivariat melalui uji chi-square dengan nilai $P < 0,05$ dianggap signifikan secara statistik. Subjek penelitian dari penelitian ini yaitu korban kasus kekerasan seksual di RSUP Dr. Kariadi Semarang Tahun 2018 – 2022 yang memenuhi kriteria inklusi. Data penelitian didapat dari rekam medis dan *VeR*.

Hasil: Hasil uji chi-square didapatkan status hubungan korban dengan pelaku memiliki hubungan bermakna terhadap pelaporan.

Kesimpulan: Didapatkan data sebanyak 124 sampel korban kasus kekerasan seksual di RSUP Dr. Kariadi yang memenuhi kriteria inklusi, kemudian didapatkan minimal besar sampel yaitu 76 yang secara random sampling diambil sebanyak 78 kasus dengan hasil analisis terdapat hubungan antara status hubungan korban dengan pelaku terhadap pelaporan.

ABSTRACT

Background: Sexual violence is any sexual or other act directed against sexuality by force in any situation regardless of the status of the relationship with the victim, including physical examination or other non-contact forms (WHO, 2017). Differences in the age of the victim and the status of the victim's relationship with the perpetrator will affect reporting to the police.

Aim: To analyze the relationship between the age of the victim and the status of the victim's relationship with the perpetrator on the prevalence of reporting sexual violence cases at Dr. Kariadi Hospital Semarang in 2018-2022.

Methods: This study used analytic observational research with a cross sectional research design, using univariate and bivariate analysis through the chi-square test with a P-value of <0.05 were considered statistically significant. The research subjects of this study were victims of sexual violence cases at Dr. Kariadi Hospital Semarang in 2018-2022 who met the inclusion criteria. The research data were obtained from medical records and VeR.

Results: The results of the chi-square test showed that the victim's relationship status with the perpetrator had a significant relationship with reporting.

Conclusion: Data were obtained from 124 samples of victims of sexual violence cases at Dr. Kariadi Hospital Semarang who met the inclusion criteria, then obtained a minimum sample size of 76 which random sampling was taken as many as 78 cases with the results of the analysis there was a relationship between the status of the victim's relationship with the perpetrator on Reporting.
