MANUSCRIPT DETAILS

TITLE: Technology Acceptance Model of the Indonesian Government Financial Reporting Information System

ABSTRACT: Changes in recognition base in government accounting standards give a significant impact to the government accounting system in Indonesia. Although the government's financial information system is a mandatory system, but the behavior of users on the system changes will determine the successful implementation of Government Financial Reporting Information System (GFRIS).

The purpose of this research is to investigate the Technology Acceptance Model on information systems of government financial reporting. The model empirically tested using data gathered from 73 respondents of Chief Finance Administration Officer, revenue treasurer, and expenditure treasurer in Surabaya city government of Indonesia. The model was tested by using the partial least squares structural equation modeling (PLS-SEM) approach.

The results provide support for the propose research model and confirm that all constructs in the TAM model were statistically significant. The findings suggest that experience has a positive impact on ease of use and usefulness. Conversely, Gender as external variables for this study has no effect on the ease of use and the usefulness of GFRIS. Findings from this study contribute to the literature on user acceptance of information system and provide insights to assess the user acceptance by focusing on user experience in the government and financial context.
