

4. Kesimpulan

Berdasarkan hasil penelitian mengenai pengalaman perawatan luka dengan metode modern dressing pada klien ulkus kaki diabetik di RUMAT Kesambi Cirebon, diperoleh empat tema utama yang menggambarkan pengalaman partisipan selama menjalani proses perawatan, yaitu respon psikologis selama perawatan, *modern dressing*, kepercayaan perawatan, serta hambatan perawatan. Secara keseluruhan, penelitian ini menunjukkan bahwa pengalaman perawatan luka dengan metode modern dressing di RUMAT Kesambi Cirebon dipersepsikan secara positif oleh partisipan karena memberikan manfaat nyata terhadap proses penyembuhan luka, meskipun masih terdapat hambatan sosial dan ekonomi yang memerlukan perhatian lebih lanjut.
