ABSTRACT

This study delves into the extensive discourse on revealing meanings in utterances within the fields of linguistics, semantics, and implicature. Its focus lies in uncovering a sapphic subtext between the characters of Louise Miller and Debbie Ocean in the movie Ocean's Eight. The term "sapphic" pertains to the sexual attraction or activity between women. Employing the analysis of implicatures, this research aims to shed light on the implicit meanings exchanged between these two characters. The complete utterances of the characters in the Ocean's Eight movie serve as the data for this investigation. This study utilizes the nonconversational observation technique during the movie's examination. The data is analyzed using the relevance theory of Daniel Sperber and Deirdre Wilson. The findings of a total of 5 (five) implicatures as well as 2 (two) subtextual emotional scenes that occurred between Debbie Ocean and Louise Miller confirm the presence of a sapphic subtext throughout the movie, underscoring the connection between Debbie Ocean and Louise Miller.
