ABSTRACT

This thesis is about the application of speech acts study to analyze characterization of a character in a movie. By analyzing utterances uttered by Clive Durham that occur in Maurice (1987) movie, this study aims to unfold his characterization using speech acts theory proposed by Searle (1979). Content analysis method was applied to conduct the data. The data were taken from utterances uttered by Clive Durham that occur in the movie which have been classified into the types of illocutionary acts. The data were identified by considering the context of the utterances and how the utterances are conveyed. The data that have been classified into each type of illocutionary acts were used to unfold characterization of Clive Durham as portrayed in the movie. The results show that there are three types of illocutionary acts performed by Clive Durham which are classified into assertives, directives, and expressives. In addition, there is no commissives and declarations that can be found in his utterances. Based on the analysis, Clive Durham is the typical person who is assertive in defending and standing up for himself, but he lacks of assertiveness when dealing with the public because of his dread of social judgment. In addition, he is also portrayed as a person who has the bravery to express his thoughts and feelings directly, knows how to behave politely and considerately, and honest in expressing his feelings.
