# 1. Background of Study

Until today when government made a laws to stop racism, the data still prove that there are still many acts of racism at this time. It is same as the situation which happened in the 12 Years A Slave a film which tell the world of slavery that occurred in America. Although racism has to be banned but in some parts of America in fact the number of slavery and racism increased in the 1800s. In America, a lot of black people were kidnapped and deprived of their liberty to become a slave and not treated as human beings in general. But in the middle of the harsh conditions at that time, the black people were still struggling to get their rights to be able to live a normal and free life like people in general

Racism is very dangerous for the ecipient of destructive behaviour and also for the one who create that act themselves. Racism acts to denigrate the target by denying it's identity, this can destroy a culture by the division of groups politically, socially and economically in a country (Samovar et al, 2010: 187-2011)

The origin of the term race is known around the year 1600. The one who says at the time there was a person who put forward the idea of human differentiation based on categories and characteristics, as well as skin color, is Francois Bernier. Because the physical, humans in the world have to be separated

by 4 groups, Black, White, Yellow, and Red. A figure told the race as a something which refers to biological and physical features is Charles Darwin, as it showed in the film *12 Years A Slave* which is a lots of scene that show a racism and slavery, but slavery comes when the white people think that black race is known as a strong people and they are poor, it was upside down with white. White people is the rich one and they had everything but not with a strong body, so they treated black badly and they did a racism.

Differences based on skin color make their races favor their own race. Darwin's theory made the whole acts for justify one race to dominate another. The race that feels they are a superior would suppress the other race. In film 12 Years A Slave, Solomon Northup is a Black free man, but he was kidnapped and treated not as a human being with white people.

A Film is a portrait of the community in which it was made. The film always records reality that grows and develops in society, and later projecting it onto the screen (Sobur, 2003: 127). The film is not only a means or medium of entertainment for people, but often films also become our means to learn and understand the things that have happened many years ago which is raised through film media such as history and biography.

12 Years A Slave is a 2013 United States-Great Britain epic historical drama film which is adapted from a 1853 memoir of the same name about Solomon Northup, an independent Negro life in New York who was kidnapped in Washington, D.C. in 1841 and sold as a slave. The White gave him a new name

"Platt", he works in a plantation in the state of Louisiana for twelve years before being released. The first edition of Northup's memoirs, edited by Sue Eakin and Joseph Logsdon in 1968, has been carefully traced and confirmed for accuracy.

Black people are considered to be an a lower caste than white people. Various methods have been used to get rid of black people, including torturing and killing them. In this film white people are shown as cruel people, but white people also act as heroes and saviors.

In this study, researchers collected the data from watching the movie 12 Years A Slave. This study is aimed at seeing how the Personal and Institutional Racism is displayed in the United States, in the film 12 Years A Slave.

#### 2. Theoritical Framework

Robert Blauner describes racism as a tendency for people who are categorized as different cultures in terms of their physical characteristics, such as skin color, hair color, facial texture, and eye shape (<u>Lustig dan Koester, 2003: 157-158</u>). Dalmas Taylor offers a related approach which focuses on the behavioral component of racism. And he explains two types of racism (Neubeck, 2001:86):

#### 2.1 Personal Racism

Personal racism occurs when a compilation of individuals (or small groups of individuals) has a suspicious attitude and or is involved in discriminatory interactions. Manifestation of Personal Racism is an individual stereotype on the basis of alleged racial differences, insulting names and references, discriminatory evaluations during interpersonal contact, challenges, and acts of violence against group members becoming inferior races.

#### 2.2 Institutional Racism

Institutional Racism is racism in institutions that involve special treatment given to minority communities. Racist institutions draw attention that groups such as Native Americans, African-Americans, Latino-Americans and Asian-Americans often find themselves victims of the routine work of the organizational structure. Unlike forms of Personal Racism, this racism occurs through day-to-day and year-to-year operations of large-scale institutions which are often difficult to detect without investigation (Neubeck, 1997: 269-277)

### 2.3 Freedom Paper

Freedom papers is documents that claimed free status of Blacks. This document is very important because "free people of color" lived with fearless of being kidnapped and sold into a slave. In *12 Years A Slave*, the police just show to the master who owned a slave to free them. With the Freedom Paper, the black people can fight back free because sometimes the white people do not know if the black people are free or not.

#### 3. Research Method

In completing this research, researchers used qualitative descriptive methods. This method is implemented by describing the data and analyzing it, in relation to the focus of the analysis. According to Bodgan and Biklein (2003: 110),

qualitative research can be used either as a primary strategy for data collection, or as it relates to observation, data analysis or other techniques. Researchers are trying to analyze this research descriptively that emphasizes on Racism in particular the types of Personal and Institutional Racism in the film "12 Years a Slave". In this research, the writer would be focusing on the type of racism in this film and discussed about Freedom Paper.

# 4.2 Institutional Racism

In this scene, Institutional Racism showed when Mr. Bass talk to Epps about the Right to had a Nigger as shown in the conversation:

Epps: "What right? I bought 'em, I paid for 'em."

Bass: "Of course you did, the law says you have the right to hold a nigger, but begging the law's pardon.. it lies. Is everything right because the law allows it? Suppose they'd pass a law taking away your liberty and making you a slave?"

White Master: "Whatever paper you hold about his freedom, it don't mean naught. He is my nigger - and I will have my day in court, sir. As God as my witness, I will have my day in court. Take 'em!"

So in this script said that "Whatever paper you hold about his freedom..." i can conclude that a pieces of paper which Sheriff and Mr. Parker is a Freedom Paper. Solomon said that he had his own Free Paper which is a document that declare of his freedom. Showed in this dialogue:

Solomon Northup talk to Mister Bass ".. Then i ask you, i begg, would you write my friends on the north, accquinting them of my situation, and beseeching them to forward "Free Papers".

#### 4.4 Racism

In the beginning of this movie showed that there are a lots of blacks on the field and there was 1 white man said "Yo fresh Niggas". Used of "special name" for certain races like in this scene specially words "Niggas" means "Negro" means "Blacks" is Racist things.

#### 5. Conclusion

In this movie, Personal and Institutional Racism reflected in film 12 Years A Slave. The scene showed Racism as a habit, because no law's to not to do Racism and Slavery at that time.
